- **RESIDENT SPACE FEE** – If either you or your group is from South Brunswick then each space you rent will cost \$20.00. *In addition, you need to provide your own table and chairs or you may reserve them through Community Unity Day, by August 15, at a specially arranged price from Friendly Rental of \$10.00 for one table & two chairs.*
- **OUT OF TOWN SPACE FEE** – If either you or your group resides in another town then each space you rent will cost \$30.00. *In addition, you need to provide your own table and chairs or you may reserve them through Community Unity Day, by August 15, at a specially arranged price from Friendly Rental of \$10.00 for one table & two chairs.*
- **FOOD VENDORS** – Each separate food concession, booth or coach will cost \$150.00 each and you need to apply for a permit from the South Brunswick Health Department. *In addition, you need to provide your own table and chairs or you may reserve them through Community Unity Day, by August 15, at a specially arranged price from Friendly Rental of \$10.00 for one table & two chairs.*
